

COMMUNITY ASSET TRANSFER EXPRESSION OF INTEREST FORM (NON-STATUTORY)

This form is not a formal Request for Community Asset Transfer under Part 5 of the Community Empowerment (Scotland) Act 2015 (the "Act").

This form should be used to **express your interest** in applying for a Community Asset Transfer (CAT) of a **particular property or land in Renfrewshire**.

Applicants wishing to apply for an asset transfer under Renfrewshire Council's Community Asset Transfer Policy are encouraged to complete this Expression of Interest Form as a first step to making a formal CAT Request. Community bodies should aim to submit this as soon as possible after they have made a decision to seek an asset transfer and have identified a suitable building or land that they wish to request a transfer of. Completion of this form will enable discussions to take place at an early stage and for the Council to check your group's eligibility and suitability for transfer of the asset identified.

Whilst fully supporting the principle of asset transfer, our CAT Policy recognises that some assets must remain under Council ownership and management, in order to support delivery of essential services or support economic activity in an area.
