Your weekly Coronavirus update

Today (Thursday 15 October), in a virtual session of parliament, First Minister, Nicola Sturgeon formally reviewed Scotland's current lockdown measures and set out new rules on face coverings.

All existing restrictions are set to continue for now including those imposed on hospitality last week and will be reviewed on 26 October. At that time, Nicola Sturgeon confirmed the Scottish Government are looking to replace the temporary restrictions with a new strategic, tiered approach to managing the virus. More on this to follow.

New rules on Face coverings

From Friday 16 October:

- Couples getting married will be exempt from wearing face coverings during their wedding or civil partnership ceremony
- Face coverings in work canteens will be required when not seated at a table

From Monday 19 October:

 Face coverings will have to be worn in other communal work areas like corridors

We'll be in touch with you shortly to confirm how face coverings must be worn in all council buildings, however in the meantime for further details go to https://www.gov.scot/

In order to prevent a further rise in cases it's essential that everyone plays their part by adhering to the guidelines and always sticking to the FACTS:


- Face coverings
- Avoid crowded spaces
- Clean hands and surfaces regularly
- Two metre physical distancing from others
- Self-isolate and book a test if you develop symptoms

Remember, if you are identified as a close contact of someone who has tested positive for Covid-19, do not come to work, inform your manager and self-isolate for 14 days.

If you haven't already downloaded the anonymous Protect Scotland app, please do so to help break the chains of infection and speed up the process of identifying people at risk of catching coronavirus.

We have partnered with Getsafeonline.org as part of Get Safe Online Week 2020 to share useful information and advice on cybersecurity.



Learning the trade




