In accordance with section 9(1) of the 2005 Act Renfrewshire Council submitted for consultation a screening report summarising its views as to whether the Renfrew Town Centre Strategy will have significant environmental effects. It simply sets out a strategy and Action Plan considering the centres strengths, areas for enhancement, regeneration and opportunities for future growth.

This includes City Deal and that Renfrew town centre will be the focus an innovative Simplified Planning Zone. The Strategy is likely to have a positive environmental effect on the area and will influence Local Development Plan 2 as it provides more detailed information provides certainty and will clarify the development options and opportunities.

The other policies in the LDP as well as the guidance framework set out by the New Development Supplementary Guidance are framed to ensure that any development does not have an adverse effect on any environmental assets.

		unlikely to lead to cumulative effects as the actions contained within the plan are for different very small and localised locations within Renfrew Centre and are expected to occur at different times and will therefore not have a significant effect on that centre. There are similar strategies for other centres within Renfrewshire and due to the nature of the small scale actions proposed across each centre there is unlikely to be a cumulative effect.

The Renfrew Centre Strategy sets out the policy framework and identifies the role, strengths and opportunities to continue to deliver improvements in Renfrewshire’s centres as well as enable adaption of the centre’s role and function where necessary and required. The Renfrew Centre Strategy focuses on Renfrew’s role within the network of centres within Renfrewshire and provides detailed proposals along with the delivery mechanisms in line with what is required by Scottish Planning Policy. The main purpose of the centre strategy is to set out the spatial elements of the Centre in a plan form indicating how centres accommodates development, changing trends and identify opportunities. It also provides the implementation tool along with a mechanism to monitor the health of this centre.

Two other projects may influence the Strategy. The City Deal programme involves investment in vital parts of infrastructure, across the eight local authority areas of Glasgow and Clyde Valley. Two projects within the programme will provide major investment in Renfrew’s transport network. A new bridge across the River Clyde from Renfrew to Yoker will improve links between Renfrewshire, Glasgow and West Dunbartonshire, while a new route west of Kings Inch Road will improve accessibility to Meadowside and Glasgow Airport. This is outwith the Renfrew Town Centre Strategy Boundary. However Renfrew Town Centre is likely to be effected and impacted on due to the increases in traffic facilities by this new crossing over the Clyde. This and the proposals for an innovative Simplified Planning Zone for Renfrew Town Centre will be subject to separate Environmental Assessment Processes.

As the Centre Strategy is primarily a reflection of LDP policy, setting out the strategy and action plan for the Centre and providing the monitoring mechanisms for a health check of that centre it is considered that the strategy is unlikely to have significant environmental effects and accordingly does not require an SEA.
