**Extended Hours for the Festive Period 2016/2017
under the Licensing (Scotland) Act 2005**

INTRODUCTION

1. Policy

It has been the normal practice of the Renfrewshire Licensing Board to make a policy for extended hours for the festive period. In previous years, this policy was considered at the Board's October quarterly meeting under the Licensing (Scotland) Act 1976 regime and a similar practice has continued under the Licensing (Scotland) Act 2005.

The Board has in terms of its current Statement of Licensing Policy at Paragraph 15.4 set out the following:-

"The Board has an existing practice permitting longer licensed hours over the festive period and that will continue to be the case. The festive period for the purposes of this aspect of the policy will be determined by the Board on an annual basis."

Accordingly, the Board now require to determine the festive period for such longer licensed hours to apply for the festive period 2016/2017.

It should be noted that many premises licence holders when making an application for a premises licence to the Board included within the Seasonal Variations section of their applications a reference to the hours to be determined by the Board in respect of their festive policy to be applied to their licences as a seasonal variation. Accordingly, such licence holders will not require to make further application to the Board for "extended hours" to cover the festive period determined by the Board. Other licence holders who have not included a seasonal variation in their operating plans are required to submit separate applications for extended hours.

2. Consultation on Festive Policy

The views of the Local Licensing Forum have been sought. The Forum are agreeable to premises operating during additional hours similar to 2015/2016. Police Scotland have indicated directly that they are also in agreement with this and do not intend to submit a separate response in relation to the festive policy, as they have in previous years.

A separate response has, however, been received this year from the Renfrewshire Health and Social Care Partnership ("the Partnership"), a copy of which is attached as Appendix 1. Within this response, the Partnership raise concerns over potential consequences of increased access to alcohol. They also refer to local initiatives which seek to raise awareness of risks associated with alcohol consumption and mitigate the harm caused by excess alcohol consumption. They ask the Board to note these concerns.

Members should also note that, in recent years, the Board have agreed festive hours policies which have been more restrictive than the hours allowed previously, following upon previous concerns raised primarily by police and health representatives. Prior to that, the "festive policy" hours had been in place for almost a decade. A festive policy has operated within Renfrewshire since the time of the former Renfrew District Licensing Board.

Having regard to Paragraph 15.4 of the Board's own Statement of Licensing Policy as set out at Paragraph 1, the Board will require to determine if they wish a similar festive policy to 2015/2016. The proposed festive hours set out below reflect the hours allowed by the Board for the festive period 2015-2016, as suggested by Renfrewshire Licensing Forum and Police Scotland.

3. Proposed Festive Policy Hours

If the Board so determine, it is proposed that the extended hours for the festive period 2016/2017 are as follows:-

"Festive Period" to be defined as the period (i) from Friday 9th December 2016 to Saturday 10th December 2016, inclusive and (ii) Friday 16th December 2016 to Monday 2nd January 2017 inclusive and the proposed policy hours are set out below.

References to the terminal hour below are to the last hour's trading on any day affected by the proposed policy and shall be construed so that the terminal hour stated will be on the morning immediately after the trading date shown, so that the terminal hour stated for Sunday 18th December 2016 in respect of on sale premises (including registered clubs) other than those with the primary purpose of offering entertainment in the form of dancing is 1am on Monday 19th December 2016.

All Licensed on sale premises (including registered clubs), except premises the primary purpose of which is to offer entertainment in the form of dancing

Terminal Hour – 1.00am	Sunday 18, Monday 19, Tuesday 20, Wednesday 21, Thursday 22, Sunday 25, Monday 26, Tuesday 27, Wednesday 28 and Thursday 29, (all December 2016) and Sunday 1 and Monday 2 both January 2017.
Terminal Hour – 2.00 am	Friday 9, Saturday 10, Friday 16, Saturday 17, Friday 23 and, and Friday 30 (all December 2016).

Terminal Hour – 3.00 am Saturday 24 December and Saturday 31 December 2016.

On Sales Premises, the primary purpose of which is to offer entertainment in the form of Dancing

Terminal Hour – 3.00 am Friday 9, Saturday 10, Friday 16, Saturday 17, Sunday 18, Monday 19, Tuesday 20, Wednesday 21, Thursday 22, Friday 23, Sunday 25, Monday 26, Tuesday 27, Wednesday 28, Thursday 29, Friday 30, (all December 2016), Sunday 1 and Monday 2 January, 2017.

Terminal Hour 4.00 am where premises are members of Paisley Town Centre Radio Link Friday 9, Saturday 10, Friday 16, Saturday 17, Friday 23, and Friday 30 (all December 2016)

Terminal Hour – 4.00am Saturday 24 December and Saturday 31 December, 2016.

4. Last Date for Applications

As indicated previously at Paragraph 1, a number of licence holders have included the Board's festive policy hours in their operating plans and no further application is required. In relation to those licence holders who will require to submit extended hours applications, it is proposed that such applications be submitted at least 28 days in advance of the first date applied for to allow for the timeous processing of applications.

5. Requirement for Notification

It has been the Board's practice for the last three years that all premises licence holders who had provided in their operating plans for a seasonal variation, in relation to the festive hours, advise both Police Scotland and Renfrewshire Licensing Board of the dates on which they intended to utilise their seasonal hours. It is proposed that similar notification be given by those licence holders by Tuesday 6th December 2016 this year.

6. Recommendations

- 6.1 It is recommended that:-
- 6.1.1 The Board agree that there be extended hours for the festive period having regard to its position as set out at Paragraph 15.4 of the Statement of Licensing Policy which indicates that the current policy of allowing longer licensed hours over the festive period will continue;
- 6.1.2 Thereafter, the Board approve the proposed hours and dates detailed in this Report for the festive period, or such other hours as the Board considers appropriate, and authorise the Clerk to take such steps as required to advise appropriate individuals and organisations of this year's festive policy;
- 6.1.3 The Board agree, in cases where premises licence holders have the benefit of festive hours included in their Operating Plans, that those licence holders require to advise the Board and Police Scotland no later than 6th December 2016 of the dates they intend to utilise their seasonal hours during the festive period;
- 6.4 The Board agree in cases where licence holders have not included the Board's festive policy in their operating plans that extended hours applications will be required. Such applications should be made at least 28 days in advance of the first date for which extended hours are sought.

SUBJECT: Festive terminal hours 2016/17

Thank you for the opportunity to comment on the proposed festive terminal hours 2016/17.

It is disappointing to note that Renfrewshire Licensing Board proposes extending the hours which people can drink alcohol over the festive period. Increased access to alcohol, which includes extending the hours in which alcohol can be purchased, is known to predicate increases the volume of alcohol that people drink.

I am sure you will appreciate that Renfrewshire has a poor relationship with alcohol and resulting health inequalities are well documented. We have amongst the highest rates of alcohol related hospital admissions and alcohol related deaths in Scotland.

Extending the terminal hours will encourage people to drink more. This can have very serious consequences for their health and wellbeing. Binge drinking is associated with increased risk of injury as a result of accident, increased risk taking behaviours and can have significant impact on health in the longer term.

Renfrewshire HSCP and Renfrewshire Alcohol & Drug Partnership (ADP) work throughout the year to minimise the harms caused by alcohol. At the request of Renfrewshire's Community Care Health and Wellbeing Thematic Board, we have implemented Brighter Renfrewshire Alcohol Awareness Week (BRAW), which aims to increase awareness of the risks associated with alcohol consumption. BRAW will be repeated during the festive period 2016 as a way of encouraging people to make sensible decisions about their alcohol consumption over the festive period. For a number of years, Renfrewshire ADP has also funded the Safe Bus over the Festive period. The Safe Bus aims to mitigate the harms caused by excess alcohol consumption by offering a point of safety in Paisley town centre for those who become intoxicated over the weekends running up to Christmas.

Extending the licensing hours over the festive period is incongruent with the objectives of these incentives, supported by the Community Planning Partners and the Alcohol and Drug Partnership.

I would ask that Renfrewshire Licensing Board note our concerns.

FOREWORD

As the Chief Constable of Police Scotland, it gives me great pleasure to provide my first annual licensing report, in accordance with section 12(A) of the Licensing (Scotland) Act 2005.

I would firstly like to take this opportunity to acknowledge and thank you for the contribution and excellent work undertaken during the past year throughout the licensing area of business in Scotland, especially within our 32 Local Authorities.

Police Scotland together with our licensing partners have faced and continue to confront many challenges, not least our budget constraints. However, this will not detract from our commitment to continuing to provide the very best and sustainable policing service to our communities across the country.

I am especially keen to develop our local services to meet the varying licensing demands and expectations within our diverse local communities, by listening to people and developing opportunities to improve, including the sharing of best practise and influencing positive attitudes and behaviours to reduce alcohol related crimes and anti-social behaviour.

Police Scotland's licensing structure and function has recently undergone significant transition and now benefits from improved governance, flexibility and support, with a real emphasis on quality of service. These changes are further enhanced through our commitment to investing and implementing a national I.T. database, (Innkeeper), which has significantly improved our management and the administration of all liquor and civic licences. Police Scotland and our licensing partners now benefit from a consistent service with improved local delivery, decision making and reporting process.

With our licensing transition complete, we are now transforming our licensing service and central to this is our ability to continue to work closely with our Local Authorities, the licensed trade and other key partners, with a main focus on prevention and vulnerability.

We recognise that problem solving is essential in achieving our mutual aims of public safety and a healthy community environment, while enforcement should only be used as necessary. We will only achieve these aims together through consent and by legitimate means with the full support of all key licensing partners.

I look forward to the coming year where we will continue to improve licensing standards, reduce violence and continue to keep our communities and people safe.

POLICE SCOTLAND LICENSING OVERVIEW

Following the inception of Police Scotland in 2013, a two tier structure for licensing was adopted to support both national and local priorities and service delivery.

A National Licensing Policy Unit (NLPU), which sits within Licensing and Violence Reduction Division, has overall responsibility for determining and delivering national licensing strategy and policy. The NLPU also provides advice, guidance and support to divisional licensing teams as well as undertaking other specialist functions.

Dedicated licensing teams are located in each of the 13 local divisions and are responsible for the day to day management of licensing administration, complying with statutory requirements as well as addressing any issues that may arise within licensed premises within their local area.

LICENSING BOARD AREA

The licensing Board area is policed by Renfrewshire & Inverclyde Division.

Chief Superintendent Jim Downie is the Local Police Commander who has the responsibility for all day-to-day policing functions.

Inspector Garry Kirkwood has the head of the licensing department, with Sergeant Jeff Curran the current licensing Sergeant.

LOCAL POLICING PRIORITIES

Following our public consultation process, the policing priorities for Renfrewshire, as set out in our Local Policing Plan are as follows;

- Drunk or Disorderly Behaviour
- Assault and violent crime
- Housebreaking and other theft
- Drug Dealing and Drug Use

Renfrewshire borders the south-west of Glasgow and contains many commuter towns and villages. It also has boundaries with North Ayrshire, East Renfrewshire, Inverclyde and West Dumbartonshire across the Erskine Bridge. Although by area it is one of Scotland's smallest unitary authorities (excluding the cities), it is one of the country's most populous areas. It is home to iconic sites such as the Braehead, the Soar Complex and Glasgow Airport, which attract over 20 million and 7 million customers per year respectively. In addition the largest of the four campuses that make up the University of West of Scotland is situated in the area. The campus occupies over 20 acres and is home to teaching, lecture rooms, workshops, laboratories and student accommodation. Renfrewshire has a rich history in effective partnership working which helps to deliver highly successful policing, impacting positively on local communities.

There are currently 441 licensed premises in Renfrewshire, 141 licensed off sales premises, 111 licensed premises for on sales only and 189 licensed premises for both on and off sales.

OPERATION OF THE LICENSING (SCOTLAND) ACT 2005

Due to the accessibility, availability and affordability of alcohol, it continues to be a principle factor in many of the incidents reported to the police. Its misuse is acknowledged as a contributor when dealing with anti-social behaviour, violence and disorder, domestic abuse and child protection.

Police Scotland working alongside our partner agencies, reduces the impact alcohol has on local communities whilst reinforcing and attaining our main priority to "Keep People Safe". Officers remain focused on issues surrounding the sale and supply of alcohol within local communities. By adopting a joint approach with partner agencies, licensed premises and individuals employed within the licensing trade, we focus and target those who fail to promote responsible trading practices.

PARTNERSHIPS

Partnership working is key to delivering tangible outcomes and we continue to strengthen our relationships with all agencies, community representatives and local residents to ensure our services are co-ordinated, effective and efficient and address the needs of our communities

Some examples of work carried out during the past 12 months include:

- Working with Renfrewshire Trading Standards, the licensing department arranged a licensing seminar for the Renfrewshire liquor licensing trade. The seminar was held on the 1st December 2015 at Oakshaw Trinity Church Hall and premises licence holders, management and staff from all on sale premises were invited to attend. Sixty persons attended the event and inputs relating to crime scene management, current drug trends and legal highs, preventing sexual violence, road policing and counter terrorism were afforded to the attendees. Attendance was up from the 2014 event and future seminars are planned which will be relevant to ongoing issues.
- "The Bar Code" Initiative - The licensing department recognised an increase in incidents involving intoxicated vulnerable, mainly elderly, patrons on leaving licensed premises. We believed that all licensed premises across Renfrewshire would benefit from additional guidance and advice on their duty of care. Having sourced funding from the Renfrewshire Alcohol and Drugs Partnership and the assistance of Renfrewshire Trading Standards and the Best Bar None scheme, a brochure known as "The Bar Code" has been produced and will be sent to every licensed premises across Renfrewshire reminding them of their responsibilities.

- The Persistent Offender Partnership is a crime reduction initiative which has been running in the division since October 2011. It applies a joint approach to identify and focus on the needs of the most persistent offenders whose crimes are committed in order to sustain their dependency on drugs or alcohol or where the addiction presents a fundamental link to offending. The programme is not dependent upon contact at the point of arrest but through shared intelligence between the partner agencies. Offenders are managed by means of robust outreach from both addiction workers and police officers providing positive encouragement to get them into treatment and eliminate excuses for offending behaviour in an effort to reduce level of offending. A key innovation of the Partnership is the integrated pro-active approach to service delivery between the Police and Renfrewshire Council coupled with strong links with other services including Greater Glasgow and Clyde NHS, North Strathclyde Community Justice Authority, Strathclyde Fire and Rescue and the Crown Office and Procurator Fiscal Service.
- Street Stuff is an award-winning project aimed at diverting alcohol fueled young people away from anti-social behaviour. It is a partnership between Renfrewshire Council, St Mirren Football Club, Engage Renfrewshire, Police Scotland and Scottish Fire and Rescue which offers a range of free activities including football, dance and the youth bus and has substantially reduced youth disorder rates across Renfrewshire.
- The Paisley Town Centre Plan is a dedicated weekend policing plan designed to tackle the issues of antisocial behaviour, violence, drugs misuse and alcohol related incidents. The plan is the main tool used by police to ensure the safety and wellbeing of members of the public whose presence fuels the night time economy of the town. It provides a targeted and coordinated approach to deter, detect and disrupt antisocial behaviour. Officers engaged in this plan take every opportunity to ensure the safety and wellbeing of individuals they may deem vulnerable or at risk and in this regard work closely with Community Wardens and Street Pastors.
- The Radiolink system provides a direct link between CCTV operators within Paisley police office and various licensed premises within Paisley, ensuring a swift and effective police response to incidents as well as providing reassurance to staff in licensed premises.
- The licensing department continue to lead multi agency operations with officers from the Home Office Immigration Enforcement (HOIE) and HMRC, targeting licensed premises, restaurants and takeaway premises within Renfrewshire. These intelligence led operations are conducted every few months and have resulted in the arrest of illegal workers and fines being imposed on their employers.

PROBLEM SOLVING

Police Scotland currently have 3 levels for categorising licensed premises that come to our attention:

- **Monitored** – premises that require extra support and supervision. This can include premises that have come to police attention through incidents or newly opened premises with inexperienced staff. Low level approach is used to address issues before they escalate.
- **Intervention** – a formal intervention agreement is put in place to improve the safe and legitimate operation of a premises. This intervention plan would be discussed with staff and a list of conditions agreed upon by all parties. The intervention period would last a minimum of three months and reviewed at its expiry date.
- **Problematic** – premises deemed problematic will be the subject of a premises licence review submission by Police Scotland to the relevant licensing board.

Any categorised premises will be subject to regular inspections to ensure compliance and will form part of the tasking regime for the Town Centre Action Plans, which are reviewed on a weekly basis.

Figures for the period 1st April 2015 to 31st March 2016 show that there were a total of fifteen monitored premises within Renfrewshire which were subject to regular inspections. One of these premises was upgraded to intervention for approximately six months and improved dramatically. There were zero problematic premises during this time.

SUMMARY

Appendices A and B provide details of all crimes/offences detected within Renfrewshire and the volume of applications processed by Police Scotland for licensed premises within Renfrewshire in terms of the Licensing (Scotland) Act 2005.

Section 1 – Unlicensed sale of alcohol – Five reports were submitted to the Procurator Fiscal against personal licence holders due to failures identified in their compliance with the conditions of their licence.

Section 22 – Objections and Representations – There were no premises applications subject to an objection or representation by Police Scotland in the previous 12 months.

Section 36 – Review Applications – One premises was the subject of a review application after failing a test purchase operation. The premises subsequently had their licence varied to contain a number of additional conditions.

Section 63 – Sale or supply outwith Licensed hours – There were no offences of this nature reported in the previous 12 months.

Section 72 – Personal Licence Applications – During the previous 12 months, Police Scotland submitted two recommend refusals to the Board. Both refusals were not upheld by the Board and both individuals had their personal licences granted.

Section 84 – Personal Licence Reviews – One individual was the subject of a personal licence review which was upheld by the Board and their personal licence revoked.

Section 94 – Exclusion Orders – There were no exclusion orders in the previous 12 months.

Section 97 – Closure Orders – There have been no closure orders issued in the previous 12 months.

Section 111-116 – Drunkenness/Disorder Offences – 16 persons were charged under these sections during this year. It is believed that many of the incidents dealt with under this piece of legislation will have been disposed of by way of a Fixed Penalty Notice rather than the statutory offences contained within this section of the Act

The total number of offences recorded under the Licensing (Scotland) Act 2005 has risen from 37 in 2014-15 to 52 in 2015-2016.

PREVENTING THE SALE OR SUPPLY OF ALCOHOL TO CHILDREN OR YOUNG PEOPLE

Police Scotland in conjunction with partner agencies continue to have a positive impact on the future outcomes for children and families, by addressing the sale and supply of alcohol to young persons, by licensed premises or by proxy (agent purchase).

Identifying young people that drink, or those on the periphery of offending through alcohol, or otherwise, will allow intervention to be progressed and consistently applied. Diversionary activities such as Street Stuff, Choices for Life and the Persistent Offenders Partnership complement ongoing enforcement activity within our communities.

233 children and young people were referred under the Early and Effective Intervention (EEI) scheme in the last year, of which 70 were noted as being drink/drugs related. Research has shown that the earlier intervention occurs the more likely children and young persons are to engage and not re-offend.

The provision of test purchasing in terms of section 105 of the Licensing (Scotland) Act 2005 is a tactic which is used where there is an underlying body of evidence to suggest that alcohol is being supplied or purchased from a particular off sales premises or that the participating premises are found within a locality where all off-sale licensed premises are being subjected to a test purchase operation, in a non-discriminatory manner, to raise awareness in relation to the illegal sale/purchase of alcohol in licensed premises.

Since the 1st of April 2015, premises across Renfrewshire were tested on 80 occasions by Police Scotland, with seven premises failures. The involved staff members and, where appropriate, premises management, were charged with offences in contravention of the Licensing (Scotland) Act 2005. One premises was the subject of a premises licence review as a result of their failure. No revocation or suspension was granted, however the premises licence was varied to contain a number of appropriate conditions.

Anecdotally there continues to be a move towards 'agent purchase' of alcohol and much less instances of children or young person's purchasing alcohol themselves however no persons were reported for this offence in the last year.

TACKLING SERIOUS AND ORGANISED CRIME

Police Scotland, operating in line with the Scottish Government Strategy for tackling Serious Organised Crime aims to keep people safe by reducing the risk of harm posed by these groups through continually targeting them.

Although not always visible, serious and organised crime is a multi-million pound enterprise with significant social and economic costs. Police Scotland have made a commitment to dismantle organised crime groups through focused intelligence gathering and continued collaborative working with communities, public and private sector bodies and key partner agencies. We will disrupt their activities such as drug supply and minimise opportunities for money laundering through the auspices of seemingly 'legitimate' enterprises, whilst using the Proceeds of Crime legislation to recover money obtained by illegal activities.

By working together to develop innovative tactics and interventions to reduce the harm and impact of such groups across Renfrewshire, we can divert offenders and those who are vulnerable to criminal gangs. This will deter illegal activities, disrupt the networks associated with serious and organised crime groups and detect offenders.

Due to the nature of their business these groups operate across sub divisional boundaries. There are currently 10 groups operating within the Renfrewshire and Inverclyde area and they have connections to the licensed trade, via second hand dealers, tanning salons and car wash premises. Police Scotland work regularly with partners at Renfrewshire council around trying to disrupt these groups through multi agency days of action. It can be difficult to link these groups to serious incidents however targeting less serious crimes has disrupted their operations.

Over the last year there has been cash seizures and restraints amounting to £4.3 million.

PROPOSED ACTIVITY FOR THE YEAR AHEAD

Test Purchase Operations

These intelligence-led operations will continue to be led by officers from the licensing department and police officers local to the Renfrewshire sub division.

“The Bar Code” Initiative

The distribution of the completed brochures will be undertaken in the first few months of the coming year.

Immigration Enforcement

The licensing department will continue to lead multi agency operations with officers from the Home Office Immigration Enforcement (HOIE) and HMRC throughout the coming year.

Innkeeper

Innkeeper is the new IT system deployed throughout Police Scotland to manage licensing. It was launched on 14th March 2016 and with the assistance of the Renfrewshire Council Licensing Section, licensing staff have been updating the system with information previously held in paper copies. This back record conversion as well as inputting of new applications will be time consuming but will ultimately lead to a more effective and efficient national electronic system.

Licensing Seminar

Plans are in place for the annual festive season seminar and consultation will be held with partners to ensure the topics are relevant and appropriate. Discussions have also been held with Renfrewshire Lawn Bowls Association for a similar type of event dealing specifically with issues appropriate to their social clubs.

NATIONAL PERSPECTIVE

Our Priorities and Policing Plans continue to be shaped by the objectives contained within Scottish Government’s Strategic Objectives and National Outcomes and the Strategic Police Plan that are delivered locally through single outcome agreements.

Consultation and engagement is combined with our own analysis of the issues likely to impact on the safety of the public to inform our local and national Strategic Assessments that identify our priorities and provide a firm evidence base for local policing teams across Scotland to deliver operational plans to prevent crime and disorder and Keep People Safe.

Our National Priorities are:

- **Violence Disorder and Anti-social Behaviour**
- **Serious Organised Crime**
- **Road Safety and Road Crime**
- **Protecting People at Risk of Harm**
- **Counter Terrorism**

The National Licensing Policy Unit (NLPU) is a specialist department which consists of a small team of officers, based in Glasgow. The officers within the unit work in conjunction with licensing colleagues, from local policing divisions. Together, they seek to ensure that legislation governing the sale and supply of alcohol and other civic licensed activity is applied and reported consistently across the country to licensing boards, in accordance with the Licensing Objectives.

During 2016/17, from a licensing perspective, our particular focus will be on the following;

- Scrutiny of the serious incidents of violence, disorder and antisocial behaviour linked to licensed premises.
- Continuous professional development training and guidance for staff to harmonise licensing practice across the country.
- Working closely with statutory partners to introduce a National Licensing Trade Forum to identify licensing related issues and prevent/reduce associated crimes.
- The implementation and ongoing development of a National ICT Licensing System, known as "Inn Keeper", to increase the efficiency and effectiveness of liquor and civic licensing administration and management.

The assistance obtained from the local authority to ensure that "Innkeeper" was implemented successfully during March 2016 is very much appreciated by Police Scotland. It is anticipated that this effective collaboration between the parties will continue to ensure that this valuable national resource remains fit for purpose and significantly improves the management of liquor and civic licensing records, documentation and information.
