#### Statement of Income and Expenditure 2023-2024

### 1. Summary

1.1. The purpose of this report is to seek the Board's approval of the draft Statement of Income and Expenditure (hereinafter "Statement") attached at Appendix 1 for publication. The requirement to publish an annual Statement was introduced in 2017.

#### 2. Background

- 2.1 Section 9B of the Licensing (Scotland) Act 2005 ("the Act") requires that the Licensing Board, on an annual basis, publish an annual report detailing the Licensing Board's relevant income and expenditure in the previous financial year. "Relevant income" includes income received in connection with the Board's liquor licensing function and "relevant expenditure" includes expenditure incurred by the Board, the Council and the Licensing Standards Officers. The Statement also requires to contain an explanation of how the amounts set out in it have been calculated.
- 2.2 The annual Statement setting out the Board's income and expenditure for the financial year to 31st March 2024 requires to be published by 30th June this year.
- 2.3 The Board's approval of the Statement at Appendix 1 is now sought to enable the above requirement to be met.

#### **Note**

The income shown above is referable to the financial year 2023-2024. Within that year, Renfrewshire Licensing Board received 3 applications for a premises licence, 6 for provisional licences, 46 for extended hours, 11 for major variation, 102 for minor variation, 35 for transfer, 1 for major variation with transfer, 108 for personal licences and 1043 for occasional licences.

The staff costs shown reflect the proportion of staffing costs attributable to the liquor licensing function based on the time spent by those staff involved in liquor licensing.

The following points may be noted:

Following a previous internal restructure, Licensing Standards Officers have been based in a wider enforcement team within the Council's Environment, Housing & Infrastructure, with more officers appointed as Licensing Standards Officers but also having other enforcement functions. For the purposes of assessing the costs of the LSOs' functions, a similar proportion of officers' time has been estimated as attributable to liquor licensing as in previous years.

No account has been taken of management costs within Environment, Housing & Infrastructure referable to the Licensing Standards Officers' functions. These officers are now again based within Finance & Resources, so the omission of such costs will be consistent with the approach to reporting in future years.

Apart from staffing costs, the other expenditure includes supplies and services and other overheads, including the central administrative support (e.g., accountancy and payroll services) attributable to the liquor licensing function.

While this report requires to be published by 30<sup>th</sup> June 2024, it has not been possible to identify central support costs with precision at this time. As such, a prudent estimate of these costs has been assumed, based on the previous year's costs with a 5% uplift applied. It is anticipated that the estimated costs may be lower than the actual operating costs, which are not presently known.

Given the above, it should be noted that the above reported deficit has been assessed on a prudent basis and that the actual deficit may be greater once actual central support costs are available.

  - (iii) A summary of the decisions made by, or on behalf of, the Board; and
  - (iv) Information about the number of licences held under the 2005 Act in the Board's area, including occasional licences.
- 2.3 The report may also contain other information about the exercise of the Board's functions, at the Board's discretion.

- 2.4 The Annual Functions Report in respect of the period from 1<sup>st</sup> April 2023 to 31<sup>st</sup> March 2024 requires to be published by 30<sup>th</sup> June this year.
- 2.5 The Board's approval of the Annual Functions Report at Appendix 1 is now sought to enable the above requirement to be met.

#### 1. INTRODUCTION

- 1.1 This Annual Functions Report has been prepared by Renfrewshire Licensing Board ("the Board") in terms of Section 9A of the Licensing (Scotland) Act 2005 ("the Act"). The Act requires this report to include the following:
  - 1. A statement explaining how the Board has had regard to
    - a) The licensing objectives; and
    - b) Their licensing policy statement

in the exercise of their functions under the Act during the financial year.

- 2. A summary of the decisions made by (or on behalf of) the Board during the financial year; and
- 3. Information about the number of licences held under the Act in the Board's area (including occasional licences).

The Board may also include other information about the exercise of the Board's functions as the Board considers appropriate.

1.2 This Annual Functions Report has been prepared for the financial year 2023-2024.

#### 2. BACKGROUND INFORMATION

- 2.1 When undertaking its functions, the Board has regard to the Licensing Objectives under the Act and to its own Statement of Licensing Policy. The Board published its current Statement of Licensing Policy, as required under the terms of the Act, in November 2023, having undertaken a review of the policy in 2022 and 2023. The new policy took effect on 4<sup>th</sup> November 2023.
- 2.2 The Act sets out the Licensing Objectives, which are:
  - Preventing crime and disorder;
  - Securing public safety;
  - Preventing public nuisance;
  - Protecting and improving public health; and
  - Protecting children and young persons from harm.

#### 3. SUMMARY OF DECISIONS AND INFORMATION ABOUT LICENCES HELD

- 3.1 Under the Act and the Board's current Statement of Licensing Policy, matters which are dealt with at a meeting of the Board are:
  - Premises licence applications;
  - Major variations to premises licences;
  - Application for transfer of a premises licence where the applicant has been convicted of a relevant offence or a foreign offence; or where a notice recommending refusal or other information is provided by the Chief Constable;
  - Personal licence applications or renewals where there is a recommendation for refusal from the Chief Constable;
  - Reviews of premises licences and personal licences;
  - · Closure orders; and
  - Refusal of any application for confirmation of a provisional premises licence
- 3.2 The Clerk and Depute Clerks have delegated authority to determine most of the applications which do not fall within the above categories, provided that there are no objections or representations received from the Chief Constable or other consultees and the application is within policy hours. If there is an objection or representation to an occasional licence or an extended hours application, or if the hours sought are outwith the policy hours, then the application will be considered by two members of the Board. In practice, one of the members who determines the application is usually the Convener of the Board. Further information on the Board's decision-making framework is set out in the Board's Statement of Licensing Policy at Paragraphs 5.3 to 5.8.
- 3.3 These delegated powers ensure that the Board provides an efficient and costeffective service to all those involved in the licensing process. At the same
  time, the delegated powers are limited to ensure that any potentially
  controversial applications are appropriately scrutinised by members of the
  Board while having due regard to the Licensing Objectives and the Board's
  Statement of Licensing Policy.
- 3.4 A summary is provided in Annex 1 of licences held in Renfrewshire in the financial year 2023-2024 (hereinafter "2023-24") and the number of licensing applications/ reviews considered, and the decisions made in relation to them. The overall number of premises licences in force at the financial year end on 31st March 2024 was slightly down on the previous financial year end, but,

unlike in the previous financial year (where there was also a marginal decrease), the number of on-sales only premises licences was unchanged, with the reduction being accounted for by off sales only premises and premises with on and off sales capacity. Similarly, no new premises licences for off sales only premises were granted, other than three provisional licences which will require to be confirmed. As in previous years from 2020-21 onwards, an increase was recorded in 2023-24 in relation to the number of occasional licence applications received and granted, with a number of premises continuing to operate external licensed areas. An increased number of personal licences was granted in 2023-24 as compared to the previous year.

- 3.5 Seven premises licence applications (including four provisional licence applications) were received/ considered during the financial year 2023-24. These were all granted with additional conditions. The conditions attached in respect of these applications were in all cases in relation to deliveries of alcohol offered by premises, with the policy conditions relating to alcohol deliveries set out in the Board's Statement of Licensing Policy being attached to the licences. The Board considered these conditions necessary for the purposes of protecting children and young persons from harm.
- 3.6 In addition to applications for proposed new licensed premises, the Board also considered 14 applications within the same period for major variation of premises licences. The Board granted these applications, but subject to further variation by way of additional conditions in eight of them. In five of these applications, the conditions were again in relation to alcohol deliveries, with the said conditions set out in the Board's Statement of Licensing Policy being attached for the purposes of protecting children and young persons from harm. In one application, a condition was attached making a requirement to give notice to Police Scotland and the Licensing Board of any funeral purveys taking place, as provided for in the Statement. In the remaining two applications where additional conditions were attached, these related to the management of external licensed areas and/or their hours of operation, for the purposes of the licensing objectives of preventing crime and disorder, securing public safety and preventing public nuisance and, in one of these cases, the above policy conditions in relation to alcohol deliveries were also attached. The other six applications were granted with no additional conditions.
- 3.7 Two premises licence review hearings called before the Board during 2023-24. In one case, the application for review was further continued to a later date and, in the other case, grounds for review were established but the Board considered no steps were necessary or appropriate for the purposes of the licensing objectives. As one of these reviews is yet to conclude, it would be appropriate to make no further comment at this time.
- 3.8 No personal licence applications were refused by the Board within 2023-24 and no personal licences were the subject of endorsement, suspension or revocation.

3.9 As stated at Paragraph 3.4 above, an increased number of occasional licence applications was received during 2023-24 as compared with the previous year. Applications for occasional licences, including those which related to external drinking areas, were considered and determined by two Members of the Licensing Board where representations or objections were received, or where conditions were requested which were not accepted by the applicant. This allowed relevant issues to be scrutinised by Board Members in appropriate cases, such as the suitability of external areas applied for, the hours of operation of external areas and children and young persons' access. The Board, in appropriate cases, attached conditions as requested by Police Scotland and the Licensing Standards Officers, including regulating external areas.

#### 4 LICENSING POLICY STATEMENT

- 4.1 The Board's current Statement of Licensing Policy ("Statement") was published to take effect on 4<sup>th</sup> November 2023. The new Statement was updated following consultation and to take account of revised statutory guidance published in January 2023.
- 4.2 In its new Statement, the Board considers that an area in Paisley Town Centre continues to be overprovided in respect of "Liquor or Pub Type Premises", being pub type premises used wholly or predominantly for the sale of alcohol. Restaurant, hotel and nightclub premises are excluded from this policy. The Board's Statement also continues to provide, amongst other things, for local conditions relating to deliveries of alcohol which provide additional safeguards to protect children and young persons from harm.
- 4.3 A similar overprovision policy has been in place for a number of years and the licensed trade and their representatives are familiar with its terms, although the new policy sets out in more detail the evidence available to the Board when they determined the terms of the new Statement regarding this matter, including evidence from police and health authorities. In the financial year 2023-24, the Board did not require to consider any applications for a premises licence or major variation which were caught by the terms of the overprovision policy.
- 4.4 As stated above at Paragraphs 3.5 and 3.6, the Board attached the conditions set out in its Statement in relation to alcohol deliveries to a number of premises licences. Where applicants sought to include off sales in, or to add alcohol deliveries to, their licence, applicants were invited to address these policy conditions in their submissions at hearings before the Board, as in previous years, and in such cases the standard policy conditions relating to alcohol deliveries were attached by the Board as appropriate. Similarly,

Licensing Standards Officers highlighted the need for such conditions in relation to occasional licence applications, where applicable, to allow officers or Board Members, as appropriate, to consider attaching similar conditions to those licences.

- 4.5 In accordance with Paragraph 15.4 of its Statement, the Board normally approves a policy on extended hours for licensed premises during the festive period. The Board agreed and implemented a festive hours policy for 2023-24, after consultation with the Licensing Forum, which was similar in scope to that which had applied in previous years.
- 4.6 The Board has otherwise had regard to the terms of its Statement in considering applications and reaching decisions under the Act in the financial year 2023- 24. All decisions were made in accordance with the Scheme of Delegation set out in the Board's Statement. As stated above, applications requiring to be considered by the Board were referred to a hearing before the full Licensing Board and occasional licence applications outwith the terms of the Board's policy, or where comments had been received, were referred to two Members of the Licensing Board for a decision to be made. In these cases, Members of the Board considered applications referred to them on their individual merits, balancing the terms of the Statement of Licensing Policy and the submissions received, with appropriate consideration of the licensing objectives.

# 5 FURTHER ACTIONS OF THE BOARD RELATING TO THE LICENSING OBJECTIVES AND OTHER INFORMATION

- 5.1 In June 2023, the Convener and Depute Clerk attended a multi-agency event held in Glasgow City Chambers regarding the operation of Local Licensing Forums.
- 5.2 Licensing Board Members held their annual joint meeting with Renfrewshire Licensing Forum on 27<sup>th</sup> November 2023. Licensing Standards Officers are members of the Forum and attend the Forum's scheduled meetings throughout the year. A Depute Clerk to the Licensing Board attends Forum meetings regularly to provide updates as required.
- 5.3 Licensing Standards Officers also attended the local Pubwatch scheme.
- 5.4 The Board's legal officers completed Continuing Professional Development (CPD) as required by the Law Society of Scotland over the course of 2023-24. In particular, officers attended courses run by Central Law Training, as well as meetings of the Society of Local Authority Lawyers and Administrators (SOLAR) Licensing Group and the Law Society of Scotland's Licensing Subcommittee of which the Depute Clerk is a solicitor member.

#### Report by Clerk to the Licensing Board

Gambling Act 2005: Review of Licensing Board's Statement of Principles

#### 1. Summary

- 1.1 In terms of section 349 of the Gambling Act 2005 ("the Act"), Renfrewshire Licensing Board ("the Board") require to publish a Statement of Principles that they propose to apply in exercising their functions under the Act for each three year period. The first Statement of Principles agreed by the Board covered the three year period from 31 January 2007. Further Statements of Principles were published in January 2010, 2013, 2016, 2019 and 2022. A Statement of Principles will now have to be agreed and published for the three year period commencing on 31st January 2025.
- 1.2 The Statement of Principles must incorporate the statutory licensing objectives and must comply with the Gambling Commission's Guidance. The Board's current Statement of Principles is available at:

The Gambling Commission from time to time issues statutory guidance, which includes relevant guidance regarding the Statement of Principles. The last guidance for licensing authorities was published in 2021 (subject to subsequent updates) and is available at: <a href="https://www.gamblingcommission.gov.uk/guidance/guidance-to-licensing-authorities">https://www.gamblingcommission.gov.uk/guidance/guidance-to-licensing-authorities</a>

1.3 Section 349(3) of the Act requires the Chief Constable to be consulted on the Statement of Principles along with one or more persons who appear to the Board to represent the interests of persons carrying on gambling businesses in the Board's area and one or more persons who appear to the Board to represent the interests of persons who are likely to be affected by the exercise of the Board's gambling functions. It is proposed that there now be formal consultation in order to allow a new Statement of Principles to be prepared and published. It is recommended that the Board in this regard consult a similar list of parties to those who were consulted during the previous consultation in 2021. The proposed consultees are listed in Appendix 1 to this report.

1.4 It is proposed that the existing Statement of Principles shall be circulated to the consultees seeking their views as to what changes ought to be made to it when the new Statement is prepared. Officers will thereafter bring a further report to the Board including a draft new Statement, seeking the Board's approval for publication. The new Statement will reflect any updates arising from changes to the guidance, necessary updates to the Appendices included in the Statement and other appropriate changes which may be proposed as a result of consultation.

#### 2. Recommendation

- 2.1 The Board is asked to:
  - (i) agree to consult with the parties listed at Appendix 1 as to the terms of the new Statement; and
  - (ii) authorise the Clerk to the Board to thereafter submit a further report to the Board with a final version of the Statement of Principles for 2025-2028 for consideration and approval.

#### 3 Background

- 3.1 A Statement of Principles must incorporate the licensing objectives stated in section 1 of the Act. which are:-
  - preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime
  - ensuring that gambling is being conducted in a fair and open way; and
  - protecting children and other vulnerable adults from being harmed or exploited by gambling
- 3.2 The list of proposed consultees contains bodies representative of people with protected characteristics to allow any equality impacts to be identified and assessed. It is anticipated that the consultation on the draft Statement of Principles will run for a period of 12 weeks, to allow an opportunity for consultees to respond.
- 3.3 Following the conclusion of the consultation period, any responses received from those consulted, or other interested parties, will be considered and, if appropriate, will be incorporated into a draft final version of the Statement of

Principles. A report on the proposed final version will then be submitted to a further meeting of the Board for consideration and approval.

Once the final Statement is agreed by the Board, officers will complete the statutory requirements regarding publication to bring the new Statement into effect on 31st January 2025.
